- 8. Student and Staff exchange programmes including Visits, training and field trips.
- 9. Educational/Vocational Courses.
- 10. Joint Consultancy.
- 11. PhD supervision.
- 12. Scientific publications.
- 13. Any other activities that are mutually agreed upon and are beneficial to both.

#### III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

#### IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After these five years it will be automatically extended for same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the Parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

#### V. NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.



From very early on, Champadanga had a steady economy based on the opulent vegetation of the area. But sadly for the local people, they missed out on higher educational opportunities. Fortunately, it was in 1971 and on the memorable birth-centenary of Rabindranath Tagore that a group of social workers, businessmen and educationists of the locality decided to setup a Begree College with a dream of bringing

Migher education to the doors of the locals. For this purpose, they formed a preparatory Committee with the following mambers. From then on, it took a few years to select a suitable place for eracting the college building, At that time, Late metal Charan mazra and his wife Late Phelubala mazta jointly donated a princely when of her 20,000/- along with a plot of 307 sataks of land by the st side of the Cld Benaras Road, about 1.5 km. away from Champin angs bus stop. A great number of local persons from cliferent strate of society also came forward with their involuable donationand timely help. A two\_storied building on the northern side of the ble pond of the domated area was built under the supervision of the Freparatory Committee. Finally, our college thabingra Mahavidya ya' affiliated to the University of Burdvan, officially started its journey on and from OSth November 1971. We heartily remember all those founder fathers, gocial workers, educationalists, businessmen, and a host of well-intended persons for their honest contributions in w setting up this College and fulfilling a their vision of making an enlightened, informed and confident local community a reality.

Initially, only eight students were admitted to the PrepUniversity course and twenty-five students to the B.Com Pass course. The official status of the institution was that of an undertaking College and the teacher and the non - teaching staff did


