

II. Purpose of the Agreement

Both the Parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through following but not limited to:

1. Joint Educational Research.
2. Community empowerment activities.
3. Exchange of Academic materials.
4. Approaches to Appropriate Government and Non-Government bodies for funding.
5. Exchange of undergraduate students.
6. Organizing and co -hosting international conferences, extension lectures, Seminars, workshops, student internship, joint projects.
7. Social and cultural programs
8. Student and Staff exchange programmes including Visits, training and field trips.
9. Educational/ Vocational Courses.
10. Joint Consultancy.
11. PhD supervision.
12. Scientific publications.
13. Any other activities that are mutually agreed upon and are beneficial to both.

III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After these five years it will be automatically extended for same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the Parties.


Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

V. NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.




VI. SPECIAL PROVISIONS



THIS MEMORANDUM OF UNDERSTANDING (the MOU) is entered on 03 .05.2023 (Wednesday) BETWEEN RABINDRA MAHAVI DYALAYA, Champadanga AND PURBASPA ECO HELPER SOCIETY, Sundarban.

RABINDRA MAHAVI DYALAYA

From very early on, Champadanga had a steady economy based on the opulent vegetation of the area. But sadly for the local people, they missed out on higher educational opportunities. Fortunately, it was in 1971 and on the memorable birth-centenary of Rabindranath Tagore that a group of social workers, businessmen and educationists of the locality decided to setup a Degree College with a dream of bringing

higher education to the doors of the locals. For this purpose, they formed a preparatory Committee with the following members, Prasad Chandra Mandal (President), Nityananda Adhikari (Secretary), Prof. Anandranath Das (Secretary), Nandlal Dutta, Panchzari Pal, Pranarishna Mandal, Baldevanath Dutta, Aniya Kumar Gupta, Ajit Kumar Maji, Sh. Anwar Ali Mirdya, Santimohan Roy, Kousikbala Pal, Kanchu Naitra, Lalit Mohan Mazra, Sh. B.J. Nazam, Sh. Goni Mirdya and Hashinath Mandal.

From then on, it took a few years to select a suitable place for erecting the college building. At that time, Late Ketu Charan Mazra and his wife Late Phelubala Mazra jointly donated a princely sum of Rs. 20,000/- along with a plot of 307 sataks of land by the west side of the Old Benaras Road, about 1.5 km. away from Champaganj bus stop. A great number of local persons from different strata of society also came forward with their invaluable donations and timely help. A two-storied building on the northern side of the big pond of the donated area was built under the supervision of the Preparatory Committee. Finally, our college 'Rabindra Mahavidyalaya' affiliated to the University of Burdwan, officially started its journey on and from 08th November 1971. We heartily remember all those founder fathers, social workers, educationalists, businessmen, and a host of well-intended persons for their honest contributions in setting up this college and fulfilling their vision of making an enlightened, informed and confident local community a reality.

Initially, only eight students were admitted to the PrepUniversity course and twenty-five students to the B.COM Pass course. The official status of the institution was that of an undertaking college and the teacher and the non-teaching staff did

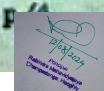

staff did not get their salary from the Government. Only in lieu of a 'pocket allowance', they were shouldering the great task of running of the new born College with utmost sincerity. Then it was in the academic session of 1972-73 that the B.A. course in the Pre-University and Degree level started. In the decade of the '80s ~~since~~ of the preceding century, a steady inflow of funds in the form of various monetary aids granted to this institution either by the State Government or by the University Grants Commission or by similar such agencies made it possible for fast-paced development of the different wings of the institution. ~~Only after four agencies made it possible for fast-paced development of the different wings of the~~ institution. Only after four decades since its inception, the College now has a pretty long list of assets to its credit, viz. five big buildings, two new buildings (under construction), a fairly spacious Library with a reading room, a beautiful playground, separate courts for playing volleyball, basketball and badminton, cycle-sheds, multi-gym, a potable water system and so on. The lush green backdrop and a big pond in the middle with thickly foliated shady trees along with its embankment truly evoke the bygone charms of a pastoral setting.



The dream has become a reality, It has now a student population of nearly three thousand and five hundred and they are offered quite a remarkable list of 18 Honours and 15 General subjects to choose from. They are also provided with other academic facilities like the Learning Resource Centre, Computerized Library Facility, Career Counselling Cell, Smart Digital Classroom etc. for their benefit. As a result, in the arena of higher education of the district, the students of Rabindra

Mahaavidyalaya, mostly hailing from the local peasant community, are able to make glorious marks at various levels of University Examinations and other competitive tests and put their Alma Mater very high on the scale of excellence. This is also borne out by the fact of achieving the grade of 'B4+' as part of the re-accreditation recently undergone by the institution and carried out by the national academic benchmarker, National Assessment and Accreditation Council (NAAC).

Any dispute will be jointly resolved by involving the Principal of Rabindra Mahavidyalaya and the Secretary of Purbasha Eco Helpline Society, Sundarban in a spirit of independence, mutual respect, and shared responsibility.
5. The MOU may be terminated by either party after giving a notice of six months (180 days) provided that this clause will be operative only if either party violates the terms of MOU or if the parties feel that no useful purpose would be served by further continuing it either due to change in circumstances or any change in the constitution or structure of the two parties entering into this MOU.
